## CONFUSED ABOUT I.L.E.E.C.P. ?

**You are not alone!** Over the past week, many of you have probably received a memo from **Karen Dozler** (ILEA) concerning your **ILEECP Certification** (Iowa Law Enforcement Emergency Care Provider). This memo is accompanied with renewal application(s) from the Iowa Department of Public Health. (**NOTE:** Not all officers will have received this memo & form as you may be on a different certification schedule rotation than even fellow officers within your own department!)

We have checked with ILEA, and YES, you are required to fill these forms out and send them back to Karen Dozler at ILEA - **NO LATER THAN JULY 1<sup>st</sup>, 2010!!** She will then forward information along to the Iowa Department of Public Health. It is suggested that you fill this form out and send it off to Karen at your earliest convenience, as well as to retain a dated copy of the filled-out form in your law enforcement in-service training files.

While the Dept. of Public Health has an interest in divesting themselves of this management responsibility, the record-keeping system is still set up to operate this way. Please observe the above procedures and deadlines in order to save yourself some grief down the road.

The information required on the renewal application form is several simple YES/NO check boxes – documenting current CPR/AED certification and 4 hours of continuing education training in specific categories over the past two years. (Training that is provided annually at our CCPOA Fall Workshop)

A copy of our course training records at ILEA since 2002 is provided below, along with a 2008 certificate. You should also reference as necessary, the training you received this spring at one of our regional workshops in March.
